REE DRUMMOND

Award-winning blogger, photographer, and celebrity chef from Bartlesville, Oklahoma who first grew a fan base around her award-winning blog, "The Pioneer Woman," Ree Drummond launched her career when she began writing about life as a cattle rancher's wife on their Osage County cattle ranch. As her content grew, including a food section filled with recipes, so did her fan base—eventually attracting over 20 million page views per month. This led to cookbook deals and her first televised appearance in 2010 on the Food Network's, Throwdown! with Bobby Flay, where she beat the celebrity chef in a Thanksgiving-themed cooking contest. The following year, her successful television series, The Pioneer Woman was launched. In 2016, Ree opened the The Pioneer Woman Mercantile in Pawhuska, Oklahoma, home of the Tallgrass Prairie Preserve. Known as "The Merc," the 25,000-square-foot historical building, purchased and renovated by the Drummonds, includes a

two-level restaurant, retail store, and bakery. The Merc attracts visitors from all fifty states (and many countries) to Pawhuska and the surrounding area. Earlier this year, she opened The Boarding House—a three-story, eight-room hotel right down the street from the Mercantile, a pizza restaurant, and an event space. A steakhouse in Pawhuska will open later this year. Ree lives on the family ranch with her husband Ladd and their four children.



CONGRESSWOMAN BRENDA LAWRENCE

Congresswoman Brenda L. Lawrence has lived in Michigan's 14th Congressional District, which includes a portion of Detroit as well the City of Southfield and 16 other cities located in Oakland and Wayne counties, her entire life. She was re-elected to the U.S. House of Representatives in November of 2018, and she serves as a Co-Chair of the bipartisan Congressional Caucus for Women's Issues and 2nd Vice Chair of the Congressional Black Caucus. AN ORGANIZATION RICH IN HISTORY

The idea behind American Mothers, Inc.® (AMI) began in 1931 when Eleanor Roosevelt announced the formation of a Golden Rule Mothers Day Committee to help mothers and children during the Great Depression. Formally organized in 1933 as a division of J.C. Penney's Golden Rule Foundation, the Golden Rule Mothers Day Committee established a fund to help Americans "Celebrate Mother's Day the Golden Rule Way" by providing financial assistance to mothers and children in need. By 1935, the organization was under the Honorary Chairmanship of Sara Delano Roosevelt, and named the first American Mother of the Year® at the Waldorf Astoria in New York City. It was the hope of the committee that she would be an inspiration to the nation.

Lucy Keen Johnson from Georgia was billed as the 'typical mother of 1935' when she was recognized as the first Mother of the Year. It was written that the celebration was simple but celebrity studded with a small luncheon and program over at CBS, followed by an informal reception before the evening NBC broadcast. At that time, the Motherhood Medal was presented to her by Sara Delano Roosevelt, the President's mother.

Lucy Keen attended Wesleyan College, the world's oldest college for women. Soon after graduation, she married Fletcher M. Johnson, a young lawyer with five children. In 1914, at age 38, Lucy was left a widow with her five step children and a daughter of her own. Lucy soon became the Dean of Women at Wesleyan College, her alma mater, while raising her children and "mothering" a sizable college community. Along

with her career and family, Lucy always found time for the concerns of others. A loyal Methodist, she served in various capacities within her church and found time for community projects. Sweet and grandmotherly, this woman of refinement had successfully met the problems of raising a family alone and accepted for all mothers the plaudits of her country as the very first American Mother of the Year.

American Mothers has annually selected an inspirational mother from nominees across the 50 States, District of Columbia, USVI and the Commonwealth of Puerto Rico for this important honor. There is a Hall of Fame plaque located in the south lobby of the Waldorf Astoria (former home of American Mothers) that lists every National Mother of the Year since 1935. Dedicated in 1970 by Honorary Chairman Mamie Eisenhower, and the Hilton Corporation, the plaque remains an iconic symbol of the mothers

of America and the rich history of this organization.

Under the leadership of Mamie
Eisenhower, American Mothers also
established a strong presence at
the United Nations and recognized
many international mothers for their
humanitarian efforts. American Mothers
continues to be recognized as a nongovernmental organization (NGO) at the
United Nations and is currently working
with other NGO's to raise awareness
about important issues that impact
mothers and children worldwide.

American Mothers is an educational 501(c)(3) organization that recognizes the invaluable contribution mothers make to the future success and happiness of children and society. Its purpose is exclusively charitable. The national headquarters is located in Washington D.C.

All proceeds were directed to "Project Recovery." She is a 2015 National Mother of Achievement Award winner and currently strives to be a "Mother of Achievement" in all aspects of her life.



GOVERNOR BILL ANOATUBBY

Bill Anoatubby began work for the Chickasaw Nation in 1975 as its health services director. A year later, he was asked to direct its finance department. In October 1978, he was promoted to the position of special assistant to the governor and controller. In 1979, he was elected as the tribe's first Lt. Governor. Governor Anoatubby was elected to his first term as Governor in 1987. In his first term, Governor Anoatubby established goals of economic development and self-sufficiency for the Chickasaw Nation and its people. Today, the Chickasaw Nation is well on the way to achieving those goals. In 1987, the tribe had about 250

employees. Today, the Chickasaw Nation employs nearly 14,000 people. The financial condition of the tribe has been improved tremendously. Funding for tribal operations has grown exponentially. Tribal assets have grown two-hundredfold. Governor Anoatubby is committed to meeting the needs of Chickasaw people through programs and services. Governor Anoatubby and his wife, Janice, have two sons, Brian and Chris and five grandchildren, Brendan, Eryn, Chloe, Sydney and Preslea.



SECRETARY HENRY G. CISNEROS

Henry G. Cisneros began his career in public service working as an administrative assistant in the San Antonio City Manager's office. He was elected to the San Antonio City Council in 1975, and became the first Hispanic Mayor of San Antonio, the nation's 10th largest city, in 1981. As a four-term mayor of San Antonio, Mr. Cisneros rebuilt the city's economic base, recruiting convention business, attracting high tech industries, increasing tourism and creating jobs in San Antonio. In 1985, he was elected president of the National League of Cities. He was nominated by President Clinton to serve as Secretary of Housing and

Urban Development on December 17, 1992. Mr. Cisneros graduated from Texas A&M with a B.A. and a masters of urban and regional planning. He earned an M.P.A. in Public Administration from the John F. Kennedy School of Government at Harvard and a doctorate in public administration from the George Washington University. Mr. Cisneros has received numerous awards and honors. 



In 1975, the American Mothers Committee published a book titled, *Mothers of Achievement in American History*. Dedicated to the organization's Honorary Chairman, Mamie Eisenhower, the book features mothers in all fifty states who were making a positive difference. Included in the publication, is a listing of each state's Mother of the Year dating back to 1935. The cherished book was sent to every Governor and a copy placed in the Library of Congress. The Mother of Achievement Award continues this tradition by recognizing women who are making a significant impact in the lives of women and children at the local, national and international level.

NANCY HUGHES

OREGON

After learning that each year more than four million people—primarily women and children—die prematurely from constant exposure to smoke and indoor air pollution from open fires Nancy Hughes was inspired to take action. Armed with the belief that cooking shouldn't kill and indeed doesn't have to, in 2008, Nancy founded the nonprofit StoveTeam International to promote the local production of safe, affordable and fuel-efficient cook stoves to replace dangerous open fires in the developing world. StoveTeam began as

a small idea from someone with a huge heart. Nancy has grown StoveTeam from an add-on to a medical mission to a nonprofit organization that has bettered the lives of over half-a-million people in just 10 years. The organization's success is largely due to Nancy's leadership and selfless devotion to clean cook stoves. Her passion, drive, and energy are infectious to those around her, reminding us all what a profound difference we can make when we put our minds AND hearts to it. Nancy won the 2011 Purpose Prize, a prestigious international award given by the Templeton Foundation and Atlantic Philanthropies to a nonprofit founder over the age of 60. In 2013, she was recognized both as a CNN Hero and a White House Champion of Change. She is the mother of two daughters and a son, and the grandmother of two. She has been the host parent to more than 50 international students.



WANDA OTERO-FLORES

PUERTO RICO

In 1997, Wanda, a licensed microbiologist, founded a Milk Laboratory for the testing and quality control of the milk produced by Puerto Rican farmers prior to its delivery to dairy treatment plants. Thus, Puerto Rican families were assured of consuming healthy milk free of disease and bacteria. As the 2008 economic crisis swept across the United States, the Commonwealth of Puerto Rico experienced its fair share of financial struggles. Dairy farmers scrambled to stay afloat. Wanda bartered with them, testing the milk in exchange

for additional milk. Nearly 10 years later, Vaca Negra (Black Cow) continues to grow as the leading provider of Dairy products. She currently provides free, professional services to over 200 farms and farmers for the testing of milk produced for the 2.3 million residents on the Island. She also speaks to mothers on the importance of first breastfeeding their infants and then considering the use of locally produced milk after that process is finished. She is a strong supporter of charitable events and has been involved in helping abandoned children. During Hurricane Maria, Wanda provided free milk to orphanage and hospital babies who would have died without nutritional assistance. She did the same for nursing homes to feed the elderly. Her many awards include the Excellence and Quality Manager of the Year, by the Puerto Rico Merchants of Puerto Rican Products Association; Microbiologist of the Year, American Association of Microbiologists (USA), and a 2017 Grant Winner of \$25,000 for Puerto Rico Shark Tank. Married for 27 years to Dr. Carlos Rivera-Casanova, she is the mother of Paulo, a veterinary major at Ohio University and Carla, a biologist and current graduate student.



DEBORAH NEAL

ALABAMA

Deborah used childhood memories and experiences as a springboard to right the injustices and unrest regarding race, gender, economic deprivation, and educational inequality that she has experienced along life's journey. She is passionate about making a difference in social justice and its reform. Deborah graduated Ohio State University with a Bachelor of Arts in Journalism. She then received a Jurist Doctor University of Missouri at Kansas City School of Law. After 11 years of practicing law in Missouri, Deborah

served as a judge for 8 years. In 2017, she joined Aid to Inmate Mothers as the Mentor Coordinator. This AIM task is for a faith-based and community organization volunteer mentor program for justice-involved women in the Montgomery, AL area communities. Her current position is a beautiful follow-up to positions such as coordinating and implementing a faith -based volunteer mentor support initiative for clients referred for case management and supervised by Missouri Probation and Parole and Johnson County Department of Correction as they reintegrated to Kansas City metropolitan communities. As a Kansas City, Missouri Municipal Judge, she rejected cases based on flagrant racial profiling by law enforcement. Deborah served as a Missouri Supreme Court appointee to statewide Gender Fairness Implementation Committee for the Missouri Courts. She testified before the Missouri legislative committees to support legislation that ended the lifetime ban for federal food stamp assistance for drug offenders. She is an advocate, a mentor, a lawyer, a wife, has been a judge, and is a tremendous example for all of us.



CINDY TRUSSEL

NEVADA

Cindy Trussel lives in Las Vegas, Nevada. She is not only the mother to five children, but also fostered and adopted three more. Cindy exceeded expectations when for eleven years she raised her children by herself, worked multiple jobs, and went beyond her capabilities in providing for her family. In doing so, she was aligned with a segment of her community that was extremely neglected. Cindy realized that she had the power to mend this broken community and build a haven of heaven and hope for those in need. She is

the founder of Lighthouse Charities and serves as its President and CEO. Based in Las Vegas, the non-profit focuses on building self-sufficiency in refugee and low-income individuals who are transitioning out of welfare. Programs focus on employment training, English classes, cultural mentoring, educational scholarships, temporary clothing assistance, and providing hygiene, household, and schools supply items. In addition, she founded three other programs. Operation Lighthouse is a non-profit booth and cultural fair offering free medical and eye exams in addition to the distribution of winter clothing. Nafasi Designs is a Job Employment Program for refugees to learn how to make and market handmade products. The Rejesha Project is a 16 week employment program that focuses on teaching and implementing important job skills such as following instructions, working in a team environment, time management and punctuality, mock interviewing, resume building, accuracy and speed, and personal responsibility.

Debbie has a national following, teaching women how to be influencers in the home and community. Debbie is the founder

of Hill Country Ministries, a non-profit Christian outreach to women. She is a columnist for the Kerrville Daily Times and a guest columnist for The Christian Post; as well as a charter writer for Bible Gateway's BGB2 blog. In addition, she is a writer for MomLife Today and A Wife Like Me; and has also served as a writer and speaker for The M.O.M. Initiative; is published in P31 Woman and other magazines, and has served on the faculty of the Michigan Maranatha Writers Conference. 




5TH GRADE **ESSAY CONTEST**

HISTORY OF THE 5TH GRADE ESSAY CONTEST

"What My Mother Means to Me," for Irene Blore, her answer to that question was "The World." Her mother was the rock she clung to in all her decisions, she said. One thing her mother always stressed was the importance of education.

"Faith and the education of my children enhance the quality of life for everyone," said Blore, the 1995 California Mother of the Year, of what her mother taught her.

As a living memorial to her mother, Blanche V. Edwards, Blore founded the Fifth Grade Essay Contest with American Mothers, Inc. in 2004. Each year since, American Mothers has sponsored the contest for all fifth grade students or the equivalent, in the public, private, and home school environment. The contest theme is "What My Mother Means to Me."

Fifth grade was chosen as the age for the contestants because that is an age when children have knowledge about writing and can begin to recognize all their mothers have done for them, said Blore. She hopes the contest encourages children to reach out to others and think

beyond themselves. The contest rules were purposely set up so that the essay must be hand-written to allow children to set aside electronic devices when working on this project and be clear of distractions.

There has been a national winner every year since 2004. The essays are always poignant and reflective of the great love and care of the mothers of this country.

"Family structure is the most important foundation of our country," said Blore. "It's so enriching to see how many have contributed to this mothers' tapestry."
